DECLARATION OF CONSENT & LIABILITY

FOR THE PARTICIPATION OF YOUNG PEOPLE UNDER 18 YEARS OLD IN THE KIDS & JUNIORS TROPHY (07.08.2026), THE IRONBIKE SHORT TRACK (07.08.2026), AND/OR THE ISCHGL IRONBIKE MARATHON (08.08.2026)

Participation in the ISCHGL IRONBIKE SHORT TRACK and the ISCHGL IRONBIKE MARATHON is allowed for participants born in 2009 or later. Participation in the ISCHGL IRONBIKE KIDS & JUNIORS TROPHY is allowed for participants born between 2010 and 2021. I am aware that participating in the competitions presents a significant physical challenge. I have adequately trained to manage the respective distance. I take responsibility for my child (son/daughter/protected person) participating in the event.

I declare that I have read and understood the participation conditions, particularly the liability clauses. As the legal guardian, I am responsible for adhering to these conditions and for any potential damages.

I am aware of the increased risk of injury to body and life as well as damage to property. I accept that the Paznaun – Ischgl Tourism Association and other involved parties cannot guarantee my safety or the safety of my child.

Participation occurs at my own risk.

I waive any claims for damages against the organizer and other involved parties in the event of injuries or damages. The organizer is only liable for intentional or grossly negligent conduct; liability for property damages and lost profits is excluded.

I assure that the date of birth provided during registration (for my child) is correct and that the start number will not be passed on to third parties.

In case of non-participation (of my child), there is no right to a refund of the entry fee or other costs (e.g., travel and accommodation expenses). Cancellation insurance is recommended.

In the event of cancellation or interruption of the event due to unforeseen circumstances (e.g., force majeure), there is no claim for execution or reimbursement (for my child).

I will inform myself independently about the sensibility of my child's participation with qualified doctors and sports experts.

The start number must be collected in person or by an authorized person. I acknowledge the above conditions as well as the liability disclaimer of the organizer.

The data will not be published, stored electronically, or shared with third parties and will only be further processed and retained for legal reasons.
