My son / my daughter / my ward has trained sufficiently for the strain and is able to cope with the respective distance, therefore I agree to a start and thus assume the responsibility in this respect.

Furthermore, I expressly declare that in the course of registration I have read and understood the conditions of participation – in particular the provisions on liability and exclusion of liability contained therein – and that I, as legal representative, bear the responsibility for compliance with the conditions and accept liability for any damage and I agree to this.

I am aware that participation in the aforementioned events is associated with an increased risk of injury to life and limb and damage to property and that and that my son / daughter / ward is exposed to dangers typically associated with this sport and that the Paznaun - Ischgl Tourist Association as organiser, as well as any (legal and natural) persons attributable to it (such as the Ischgl Ski Club or the Ischgl Mountain Rescue Service), cannot guarantee my safety. participation or if he / she injures himself / herself or third parties, I will not assert any claims for compensation of any kind whatsoever against the organiser or any persons (legal and natural) attributable to the organiser. The organiser as well as any (legal and natural) persons attributable to it (including employees and organs of the organiser, etc.) shall be indemnified and held harmless for all damages.

The organiser shall be liable for damage to property or financial loss caused by it as well as other damage exclusively in cases of intentional or grossly negligent conduct. This limitation of liability does not apply to personal injury. Liability for pure financial loss, consequential loss and loss of profit is excluded entirely, regardless of the degree of fault.

I confirm that my son's / daughter's / ward's date of birth stated in the registration is correct and that the start number will not be passed on to any other person.

If the participant is prevented from taking part, he/she is not entitled to a refund of the entry fee or to compensation from the organiser for other damages, such as travel and accommodation costs. When registering, taking out cancellation insurance is recommended. In the event of cancellation or abandonment of the respective event due to unforeseen circumstances (in particular force majeure and imminent danger) or for reasons for which the organiser is not responsible, there shall be no claim to performance and no claim to reimbursement of the entry fee and also no claim to compensation for other damages, such as travel and accommodation costs.

I am also hereby informed of the possibility of obtaining information and recommendations on the advisability of a start for my son / daughter / ward from qualified doctors and sports experts at my own responsibility.

The start number must be collected personally by the respective legal representative or the coach or another authorised person.

I expressly accept the above conditions as well as the organiser's exemption from liability and the conditions of participation.

The personal data collected here (legal representative and child/guardian) will only be used for this Declaration of Consent & Liability in the context of the KIDS & JUNIORS TROPHY, ISCHGL IRONBIKE SHORT TRACK and ISCHGL IRONBIKE MARATHON and will be destroyed after 40 months. The data will not be published, electronically stored or passed on to third parties and will only be further processed and kept longer if legally required. The processing of this data is covered by the legal basis Art 6 para 1 lit b GDPR.
